

# MINUTES OF THE 28TH ANNUAL GENERAL MEETING OF THE INSTITUTE OF SOUND, COMMUNICATIONS AND VISUAL ENGINEERS LIMITED HELD ON TUESDAY, 25 MARCH 2025 at Coombe Abbey, Binley, Leicestershire

## 25.04 Report by the incoming President

Jim Smith FInstSCVE, introduced himself and requested the AGM attendees join him in thanking outgoing ISCVE President Neil Voce MInstSCVE for his amazing contribution to the ISCVE during his term as President. Jim mentioned a number of initiatives which Neil has been instrumental in prompting and developing, including the VA Manifesto. Jim went on to outline his vision for the ISCVE over the next few years which includes attracing a more diverse and inclusive membership, promoting early careers, technical excellence and reinforcing Environmental Social and Governance as a core value of the ISCVE.

## 25.05 2024 Year End Accounts

Net Loss for 2024 is -£2,943

This was due to the following factors:

- Investment in new ECS order portal
- Investment in new Registered Installer scheme.
- Writing off bad debts from lapsed members (accumulated over past 4 years)
- Outstanding membership fees
- Fewer training courses scheduled in 2024

Current Account Balance is £71,372.27

Fixed Asset Investment Net Book Value is £44,954

Bounce Back Loan of £32,615 is now at a reduced balance of £9,637.46

The 2024 Year Accounts were proposed by Doug Edworthy HonFInstSCVE, seconded by John Willett MInstSCVE and were approved by all members in attendance.

## 25.06 Authorising Council to fix the fee of the Accountants
