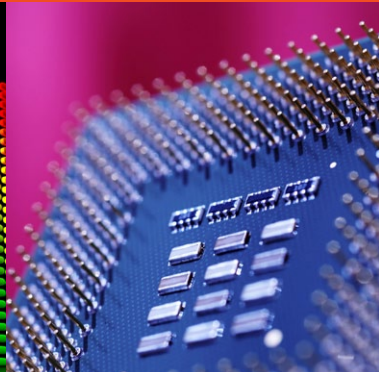
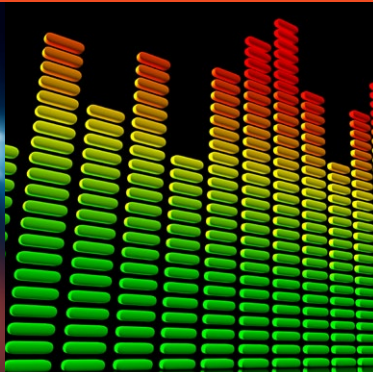

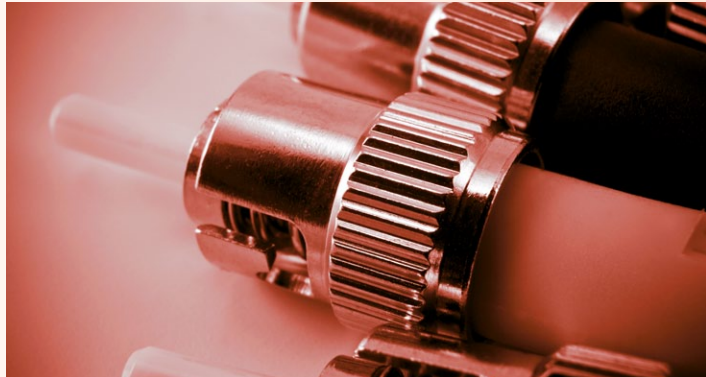

Grades and designations

The following grades of membership are available within the Institute

- **Student** – someone receiving full-time training and/or preparation for employment within the industry.
No designation
- **Graduate** – someone with a Bachelors degree equivalent or higher in a technical subject and seeking employment within the industry.
Designation – GradInstSCVE
- **Associate** – someone with an interest in, but not actively employed in a technical role.
Designation – AInstSCVE
- **Technician** – someone with a standard of general education and technical competence or industry training and been employed in the industry for not less than one year.
Designation – TechInstSCVE
- **Senior Technician** – someone with a high level of technical expertise within an appropriate technical subject, experience within the industry, or be employed in a supervisory position within an established organisation.
Designation – SenTechInstSCVE
- **Member** – a senior category for someone with suitable qualifications and experience, hold a responsible position and apply extensive technical, but not necessarily academic knowledge within the industry.
Designation – MInstSCVE
- **Affiliate Member** – a senior category for someone, while not being qualified either academically or by extended experience, making a significant contribution to the industry.
Designation – AMinstSCVE
- **Fellow** – someone of technical eminence in the field and is awarded entirely on outstanding contribution to the Institute or the industry, as determined by Council.
Designation – FInstSCVE
- **Companion** – someone of honour and respect in the field, and is awarded entirely on outstanding contribution to the Institute or the industry, as determined by Council.
Designation – ComplnstSCVE
